Do Not Dilute - Shake gently prior to use

#### For Spray & Dropper Applications:

- 1. Restrict the use of the lubricant to the area of the instrument requiring lubrication using the sprayer.
- 2. Allow the MedLube to penetrate the joint for about 30 seconds
- 3. Test the action of the lubricated joint to ensure penetration
- 4. For exceptionally stiff instruments re-apply and actively open and shut the instrument, until loosened.
- 5. If the lubricant dislodges dried contaminants from the joint. The instrument(s) will require recleaning.
- 6. Seized instruments may require treatment by immersion in a bath of MedLube.
- 7. Do not rinse
- 8. Wrap
- 9. Sterilize
